- 1. 10:10AM Roll Call (C. Mack)
- 2. 10:15AM NYBC Plans for 2017 (P. Winkeller)

Winkeller: Discussed the Plans for the NYBC in the upcoming year:

- Developing the **Long Island Chapter**
- Expanding the NYBC resources into education, tourism, health safety and legislative advocacy campaigns
- Convene a **Bike Summit** in Albany, highlighting workshops and plenary sessions, oriented more towards "how" rather than "why" (Friday, September 15, 2017)
- Passing legislation for the legalization of pedal-assist 20 mph Electric Bikes
- Attaching the three-foot passing law to the Move Over legislation
- Promoting the executive message about bike safety, bike access, completing the canal, and other bike issues statewide

Mangan: Is there support from law enforcement officials for the three foot passing law? Winkeller: Not in writing, but law enforcement representatives have been receptive in meetings.

Winkeller: Looking to support a new US Bike Route, potentially converting NY Bike Route 9 into a US Bike Route, from Ontario to Pennsylvania and further south. Benware: The application was made to the AASHTO Committee designating US Bike Routes, there was an administrative issue with the application, and the application will likely be revised and resubmitted.

 - a. NYSDOT Bicycle & Pedestrian Program Office of Traffic Safety and Mobility (OTSM):
 - Bike Map / GIS:

Benware: Continuing to develop the mapping data and integrating into the QGIS platform. It is unclear at this point if the MPOs will have direct access to update and modify the mapping data, although the MPOs would be the most knowledgeable about specific details of the features, such as condition, lanes, and markings.

Pedestrian Safety Action Plan - PSAP

Benware: The PSAP is moving ahead with a design services contract that regions will be able to utilize to evaluate locations and install low cost countermeasures, or identify more complex safety enhancements for further evaluation and implementation. There are three contracts in development with consultants based on geography: eastern (regions 1, 2, 7, and 9) to be serviced by VHB, western (regions 3, 4, 5, and 6) serviced the CMA, and southern (region 8, 10, and 11) serviced by GPI.

NYSDOT continues to have monthly meetings with the GTSC and DOH on implementation of the PSAP. The focus for 2017 will be installation of low cost counter measures, with evaluations of the more complex improvements to follow.



TAP / CMAQ Update (L. Ford / T. Benware):

Ford: TAP and CMAQ applications were due in October. The regions have reviewed, weighted, and ranked the applications, providing recommendations to the Main Office. The Main Office will review the allocations between the rural, small urban, large urban and CMAQ "buckets". The final decisions will be reviewed with the Governor's Office and OSC, with an announcement expected towards the end of January.

4. 10:45AM – Work Plan Implementation

a. Complete Streets – MPO / Region Initiatives (All)

Reigle: Continuing to compile local Complete Streets Policies and integration of complete streets applications into regional Long Range Transportation Plans; please continue to send information to Scott Reigle and Corey Mack to incorporate into the NYSAMPO website.

Burns: NYSDOT maintains a similar complete streets policy and resolution database for villages, towns, cities, and counties here: https://www.dot.ny.gov/programs/completestreets

Cunningham: Worked with Albion on a mill and fill project to add bike lanes where appropriate, and shared lanes when adjacent to parking. The economic benefits helped gather support for the lanes and infrastructure.

Mack: Asked for experience converting hilly terrain into an uphill bike shoulder and downhill shared lane. Burns: Alleghany County describes some complete streets applications in rural areas.

c. Work Plan Update 2017-2018 (All)

The group discussed the 2017 Bicycle and Pedestrian Working Group Work Plan, and comments received on the work plan to date. In general, it was discussed that the Working Group should avoid adding new tasks.

Discussion highlights:

- Goals Section: Possibly incorporate data sharing (count, crash, collection methodology) and assisting in achieving statewide safety performance targets into Goal #1
- Task #4: J. Arey comment acceptable, but needs some modification for readability
- Task #7: J. Arey comment acceptable, but modify wording to "encourage" MPO access to NYSDOT trail / path database



- Task #11: "Support" legislation may encroach into advocacy, perhaps "track and participate in" or "inform the discussion" would maintain more neutrality in the legislation
- Do not recommend having the specific I-81 Border Crossing enhancement project as a work plan task, but perhaps identifying critical limited access highway barriers to bicycle and pedestrian access statewide would be a good first step to addressing site specific issues
